WHY is the CCCCO collecting the Student Nursing data?



Ed Code 88826.5

- (a) (1) Beginning in July 1, 2019, and in each year thereafter, except as provided in paragraph (2), for each community college program that offers certificates or degrees related to allied health professionals, the chancellor shall provide a report to the Legislature, with comparative clinical placement delineated by program and occupation. The report shall include both of the following:
- (A) The number of students participating at each clinical training site. This shall include information about proficiency in languages other than English.
- (B) The license number of each clinical training site. If the license number is not available, the report shall include the employer identification number of the clinical training site.
- (2) Beginning in the 2025–26 fiscal year, the chancellor shall provide the report described in paragraph (1) to the Legislature biennially, on or before March 1, and may submit the report with the report required by paragraph (2) of subdivision (h) of Section 78261.



Ed Code 78261

- (g) As a condition of receiving grant funds pursuant to paragraph (2) of subdivision (d), each recipient community college district shall report to the chancellor's office the following data for the academic year on or before a date determined by the chancellor's office:
- (1) The number of students enrolled in the nursing program.
- (2) The number of students taking diagnostic assessments.
- (3) The number of students failing to meet proficiency levels as determined by diagnostic assessment tools.
- (4) The number of students failing to meet proficiency levels that undertake preentry preparation classes.
- (5) The number of students who successfully complete preentry preparation coursework.
- (6) The average number of months between initial diagnostic assessment, demonstration of readiness, and enrollment in the nursing program for students failing to meet proficiency standards on the initial diagnostic assessment.
- (7) The average number of months between diagnostic assessment and program enrollment for students meeting proficiency standards on the initial diagnostic assessment.
- (8) The number of students who completed the associate degree nursing program and the number of students who pass the National Council Licensure Examination (NCLEX).



CCCCO Nursing/MIS/Research

- Create required reports for Legislature and Governor
- Conduct analysis and research on nursing programs
- Advocate for funding and resources for nursing programs



Student Nursing (SN) Approval Timeline

- November 4, 2024 Allied Health and Nursing Data Elements request submitted by CCCCO Nursing staff
- December 2, 2024 new MIS file recommendation
- March 28, 2025 memo RAD-400-001 announcing new MIS SN file
- April 17, 2025 CCCCO MIS Update Webinar
- August 26, 2025 email clarifying SN file due date
- November 17, 2025 MIS Nursing Data Submission Webinar



HOW is the Student Nursing data being collected?



CCCCO MIS Data

- Statutorily mandated collection of unitary datasets from CCC districts
- Ed Code 71020.5 & 84754.5 relate to the MIS data collection
- Datasets include Students, Courses, Enrollments, Program Awards, Financial Aid, District Employees, etc.
- Data is submitted by CCC districts on a term or annual basis depending on the type of data being submitted







WHAT should be included in the Student Nursing data file?



Student Nursing (SN) File Domain

- An annual file containing details of student participation in nursing programs
- Records are reported at the distinct college/student/nursing program level
- Nursing programs include programs approved in the Chancellor's Office Curriculum Inventory (COCI) under TOP code 1230.##
- Students who applied and/or participated in a nursing program at a college in the district during the academic year should be included

- SN04 Nursing-NCLEX-Date

Student Nursing (SN) Data Due Date

- Student Nursing (SN) data is submitted annually in fall for the previous academic year
- For Student Nursing (SN) data purposes, an academic year is considered to include summer, fall, winter, spring terms
- Student Nursing (SN) data is due by November 30
- Data can be resubmitted at any time to correct errors or omissions



Student Nursing (SN) Implementation


- Student Nursing (SN) data submission for 2024-25 (term 250) is encouraged, but not required
- Student Nursing (SN) data submission for 2025-26 (term 260) is mandatory
- Districts unable to submit 2024-25 SN file due to unavailability of data locally should focus on implementing local collection and reporting to meet the required 2025-26 SN file submission

MIS Data Flow






Recommendations for Nursing Program Directors

- Familiarize yourself with the Data Element Dictionary
- Determine where data resides in your system
- Collaborate with your MIS data submission staff
- Review preliminary reports
- Run periodic reports throughout the year
- Make quality data submission a priority
