

MIS Data Submission





CCCCO MIS Data Collected from Districts

- Student, Course, Enrollment, Program Award, Financial Aid, Employee, etc.
- Data submitted on a term or annual basis depending on the type of data







Student Demographics (SB) File



Student Demographics (SB) File

- Submitted after each term
- Contains one record per college/term/student
- Records should be reported for all students meeting domain criteria
- Elements include student parameters such as name, birthdate, gender, ethnicity, education status, enrollment status, etc.



Student Demographics (SB) File Domain

Include a record for every student who meets any of the following criteria at the college during the term:

- Qualifying enrollment (resulted in a notation on the student's official record)
- Participated in/received a service from a student service program (DSPS, EOPS, CalWORKs, SSSP, MESA, Umoja, CAFYES, A2MEND, Rising Scholars, etc.)
- Received a financial aid award



SB File Error Troubleshooting

- SB file edits are mostly syntactical and quality
- Education Status (SB11) and Enrollment Status (SB15) must agree
- Education Status (SB11) and High School (SB12) must agree for special admit students



SB File Data Quality Edits

- **SB08** More than 5% of credit students have zip code set to 'unknown'
- **SB09** More than 20% out of state residency status for credit students
- SB11 More than 25% unknown education status for credit students
- **SB14** More than 70% of credit students have "unknown" goal
- **SB14** More than 70% of credit student have "not applicable" goal
- **SB15** Less than 50% continuing enrollment status for credit students
- **SB15** More than 10% unknown enrollment status for credit students

- SB22 More than 50% of credit students have 'unknown' academic standing
- SB22 More than 50% of credit students have 'not applicable' academic standing
- SB22 100% of credit students have good academic standing
- **SB26** More than 3.5% of students are flagged as WIA participants
- SB29 More than 15% unknown ethnicity for credit students
- SB33 Not a single student with known parent education status
- SB34 More than 25% of students do not have a CCC ID ('XXXXXXXX')



Student Identifier (SB00) Updates



Student Identifier (SB00) Updates

- SB00 can be reported as SSN, ITIN, or district assigned unique identifier
- SB01 indicates the type of identifier reported in SB00
- Student identifiers used in previous submissions can be batch updated through the Student Identifier (SB00) Update process
- District may submit update request file containing old and new SB00/SB01 values
- Process produces report listing status of each update
- Sequence of student identifier updates and data submissions



Special Populations (SG) File



Special Populations (SG) File

- Submitted after each term
- Contains one record per college/term/student
- Records should be reported for all students meeting domain criteria
- Elements include...
 - Student characteristics, such as current and former military service, foster youth, juvenile or adult justice impacted, etc.
 - Student service program participation, such as MESA, Puente, Umoja, etc.
 - Student educational program participation, such as Baccalaureate program, dual admission program, etc.



Special Populations (SG) File Domain

Include a record for every student who meets either of the following criteria at the college during the term:

- Qualifying enrollment (resulted in a notation on the student's official record)
- Participated in/received a service from a student service program (DSPS, EOPS, CalWORKs, SSSP, MESA, Umoja, CAFYES, A2MEND, Rising Scholars, etc.)



SG File Error Troubleshooting

- SG file edits are mostly syntactical
- Active Reserve and National Guard service must be internally consistent
- If any record is reported as not applicable (such as when a college does not offer a specific student service program), all records must be reported as not applicable
- Baccalaureate program control number not found
