- Allow student identifier to be reported as ITIN
 - SB00 STUDENT-IDENTIFIER
 - SB01 STUDENT-IDENTIFIER-STATUS
- Allow goal to be reported as "Obtain a CCC Baccalaureate Degree"
 - SB14 STUDENT-EDUCATIONAL-GOAL
- Collect student email address
 - SB40 STUDENT-EMAIL-ADDRESS



SF Student Financial Aid Element Changes

- Collect Student Aid Index (SAI)
 - SF23 STUDENT-AID-INDEX
- Collect Ability to Benefit (ATB)
 - SF24 STUDENT-AID-ABILITY-TO-BENEFIT



SF23 STUDENT-AID-INDEX format

SF23 STUDENT-AID-INDEX format is X9(6)

- Position 1 is +, -, or X
- Positions 2 through 7 numeric, right justified, with leading zeros before the first significant digit
- +001500 = 1500
- -000300 = -300
- \bullet +000000 = 0
- X000000 = unknown/not reported

If a code of "Y" is reported for this data element, all of the records in the file must have a code of "Y". The data element cannot be self-reported; student participation in the program must be verified by the college.
